MEMORANDUM OF UNDERSTANDING FOR THE ESTABLISHMENT OF A METROPOLITAN PLANNING ORGANIZATION (MPO)

Whereas, the Chief-Elected Officials of the South Western Region, the Transit Districts within the Region, and the South Western Regional Planning Agency have been requested by the Department of Transportation of the State of Connecticut to form a Metropolitan Planning Organization (MPO), to provide a mechanism by which the Region's Chief-Elected Officials and Transit Districts can act jointly on the transportation planning policy and on the choice of transportation projects to receive federal aid.

Now therefore, it is understood that the signatories to this Memorandum of Understanding agree to the creation of a MPO and to the following process.

A. Metropolitan Planning Organization (MPO)

- The MPO shall be comprised of the Chief-Elected Officials of the South Western Region and one Director from each Transit District of the South Western Region.
- The Chairman of the South Western Regional Planning Agency will sit on the MPO as a non-voting member, representing the South Western Regional Planning Agency and serving in an advisory capacity.
- 3. The MPO in cooperation with ConnDOT and South Western Regional Planning Agency shall be responsible for:

a. <u>Urban Transportation Planning</u>

Providing policy direction on all aspects of the transportation planning process, as provided by the Federal-Aid Highway Act of 1962, as amended; the Urban Mass Transportation Act of 1964, as amended; the Airport and Airway Development Act of 1970, as amended; the Housing and Urban Development Act of 1954, as amended; the National Environmental Policy Act of 1969, as amended and the Intergovernmental Cooperation Act of 1968, as amended, and regulations issued pursuant thereto.

b. Planning Work Program

Adopting an annual unified planning work program which details all transportation and transportation-related planning activities anticipated within the year.

c. Transportation Plan

Annually validating or adopting a comprehensive, integrated and multimodal transportation plan that is consistent with current transportation and land use conditions of the region.

d. Transportation Improvement Program

Directing in accordance with federal regulations, the cooperative development and annual update of a comprehensive, integrated and multimodal transportation improvement program and endorsing the

annual update and any amendments thereto.

- 4. The MPO shall operate under the following decisionmaking procedures:
 - a. Any official actions taken by the MPO will be by vote.
 - b. Each Chief Elected Official will have one vote.
 - c. The Transit Districts will have a total of one vote, representing however many transit districts that are presently in existence.
 - d. Any action by the MPO shall be by a majority of the membership constituting a quorum, which shall consist of two-thirds of the total voting membership.
 - e. The MPO may not endorse a local non-transit plan or program affecting a town within the Region unless the Chief-Elected Official of the municipal government to be responsible for its implementation votes in the affirmative. In the case of transit plans or programs in that town, the Transit District must vote in the affirmative on that plan or project.
 - f. As a matter of right, any voting member of the MPO may request and obtain a separate vote on any particular plan, project, or program referred to the MPO for consideration and action.

B. Transportation Planning Agency (TPA)

- 1. South Western Regional Planning Agency shall be the TPA for the South Western Planning Region.
- 2. As TPA, South Western Regional Planning Agency in cooperation with the MPO and ConnDOT, shall be responsible for:
 - a. Directing the transportation planning activities contained in the adopted annual unified planning work program.
 - Contracting with federal, state, and local agencies to receive and disperse planning funds to carry out the adopted annual unified planning work program.
 - c. Shall provide staff to serve as Secretary to the MPO.

C. Transportation Technical Advisory Group (TTAG)

- 1. The TTAG shall consist of technical representatives from:
 - a. The Transportation Planner of the South Western Regional Planning Agency, who will act as Chairman of the TTAG, and will be responsible for the timely flow of material to and from the MPO.
 - b. The Connecticut Department of Transportation
 - c. The Transit Districts within the South Western Region.

- d. The technical representatives (planning, traffic engineering, etc.) of the cities and towns of the South Western Planning Region.
- e. The Federal Highway Administration, Urban Mass Transportation Administration, and other interested federal agencies.
- 2. The TTAG will operate under the following procedures:
 - a. Projects or Programs proposed for initiation by the Connecticut Department of Transportation, individual towns, or transit districts will be forwarded to the South Western Regional Planning Agency (SWRPA) for discussion at the next TTAG meeting.
 - b. The TTAG will meet with and at the call of the staff of the South Western Regional Planning Agency, on an as-needed basis, to discuss specific projects and proposals, and to formulate a cooperative draft resolution for consideration by the MPO.
 - c. The Transportation Planner of SWRPA will ask the MPO to convene -to-take-action on proposed resolutions.
 - d. SWRPA staff will record the minutes of the MPO meeting and forward decisions to the Connecticut Department of Transportation and the Urban Mass Transportation Administration.

D. Other Provisions

Non-limitation of Statutory Authority

Nothing contained in this MEMORANDUM OF UNDERSTANDING is intended to or shall limit the authority or responsibilities assigned to individual signatory agencies under State or Federal law.

Amendment

This MEMORANDUM OF UNDERSTANDING may be amended upon execution of a revised Memorandum of Understanding. Agreement to this Memorandum of Understanding by the signatures affixed hereto shall supercede agreement by the signatories to any such prior Memorandum of Understanding.

Except for those provisions relating to membership, participation, and voting, this revised Memorandum of Understanding may be amended at any meeting by a majority vote of the MPO present and voting. Any amendment may be presented for disposition by such vote of the MPO at any such meeting thereof, provided that not less than ten (10) days' written notice of the proposal to effect such amendment has been given to each member of the MPO.

Effective Date

The effective date of this MEMORANDUM OF UNDERSTANDING shall be the date that it has been signed by the Agency Chairman and by at least the Chief-Elected Officials of five out of the eight municipalities and two transit districts.
