Overview:

The United States Department of Transportation (DOT) has issued a Notice of Funding Opportunity (NOFO) for the FY16 Transportation Investment Generating Economic Recovery (TIGER) discretionary grant program. TIGER seeks to award projects that advance the DOT's strategic goals for the nation's transportation system, found in their <u>FY14-FY18 Strategic Plan</u>. Successful projects leverage resources, encourage partnership, catalyze investment and growth, fill a critical void in the transportation system or provide substantial benefit to the nation, region, or the project's metropolitan area.

Total Funding: \$500 million (discretionary); **Max Award**: \$100 million, **Min Award**: \$5 million (\$1 million for rural areas).

Cost Share/Match: <u>Urban Area</u>: up to 80% federal; <u>Rural Area</u>: up to 100% federal.

Eligible Projects: include, but are not limited to:

- Highway or bridge projects eligible under Title 23
- Public transportation projects eligible under 49 U.S.C. Chapter 53
- Passenger and freight rail;
- Port infrastructure investments; and
- Intermodal projects.

Overview:

The United States Department of Transportation (DOT) has issued a Notice of Funding Opportunity (NOFO) for the Advanced Transportation and Congestion Management Technologies Deployment Initiative (ATCMTD) discretionary grant program. The ATCMTD will provide annual funding for the large-scale implementation and operation of advanced transportation technologies. The program promotes the use of innovative transportation solutions, which will provide Congress and DOT with valuable real life data and feedback to inform future decision making.

Purpose: to reduce costs and improve return on investments; deliver environmental benefits through increased mobility; improve transportation system operations; improve safety; improve collection and dissemination of real-time information; monitor transportation assets; deliver economic benefits; and accelerate deployment of connected/autonomous vehicle technologies.

Total Funding: \$60 million annually (discretionary, through FFY 2020); Max Award: \$12 million.

Cost Share/Match: up to 50% federal match. Details are provided in Section C-2.

Eligible Applicants: include state or local governments, transit agencies, MPOs with a population > 200,000, and others as described in Section C-1.

FTA 5310 Program: There is approximately \$1.3 million statewide. Each MPO is to set priorities for grant applications to CTDOT for wheelchair accessible vans serving seniors and persons with mobility impairments, also for projects and activities supporting same.

It was noted that for past application cycles HARTransit had managed program administration for HVMPO, and for this cycle is so serving both HVMPO and SWRMPO, reviewing and ranking applications received utilizing CTDOT's criteria and point system.

CT State Matching Grant Program: Provides matching funds for the transportation of senior and disabled populations, each municipality eligible for a predetermined programmed amount, including flexibility to pool resources at a regional level or with a transit district. Contact information in the agenda packet.

National Transit Map initiative: Rob Sachnin spoke to this initiative, which seeks to create a National Transit Map displaying stops, routes and schedules for all participating transit agencies. USDOT is asking for access to each transit agency's "General Transit Feed Specification" (GTFS) to populate the map and corresponding web application.

It was noted that Norwalk Transit District has GTFS data and HARTransit will soon have their data in this format. Additional information on participation is in the agenda packet.

CMAQ Program Follow-Up: The four successful applicants from the WestCOG region, Greenwich, Stamford, Norwalk and HARTransit, were congratulated on their accomplishment.

HVMPO FFY 2015-2018 Transportation Improvement Program (TIP) Amendments (04/21/2016)

The three CTDOT requested TIP Amendments explained below pertain to funding received statewide as part of the federal Congestion Mitigation and Air Quality (CMAQ) program. The purpose of CMAQ is to fund transportation projects and programs that will improve air quality and reduce congestion. As an example, the Housatonic Valley MPO region received CMAQ project funding in 2015 to help fund transit service provided by HARTransit to the newly constructed Belimo manufacturing facility located on the west side of Danbury.

The purpose of the three programs being added to the HVMPO TIP as a result of these amendments is described as follows:

TIP Amendment #170-3400 - FY-2016: Statewide Transportation Demand Management

Travel/transportation demand management (TDM) is an eligible usage of federal and state transportation funding and encompasses a diverse set of activities to support better decision-making for travelers choosing travel modes, times, routes, and locations. A goal of TDM is to optimize performance of local and regional transportation networks. Projects can help ease congestion and reduce single-occupancy vehicles.

Using selected contractors, CTDOT will market, educate and provide outreach to employers and individuals in support of CTDOT's regional rideshare program in the Southwest, Danbury, Bridgeport, Greater New Haven and Waterbury areas of the state. This program assists in the formation and long-term viability of carpools. This program is designed to reduce traffic congestion, energy consumption and air pollution.

<u>Task 1</u>: Southwest, Danbury, Bridgeport, Greater New Haven and Waterbury Services Supporting Carpools and Vanpools to Individuals

<u>Task 2</u>: Southwest, Danbury, Bridgeport, Greater New Haven and Waterbury Services Supporting Carpools and Vanpools to Employers

<u>Task 3</u>: Statewide Guaranteed Ride Program and Web-based Incentive Ride Network

TIP Amendment #170-3402 - FY-2016: Telecommuting Partnership

Telecommute Connecticut is a part of the CTrides program offered by the Connecticut Department of Transportation, with the support of the Federal Highway Administration. The program offers a comprehensive resource that helps employers to design, implement and maintain telecommuting programs that, while being effective for employers, also result in reduced traffic congestion, energy consumption and air pollution.

Telecommute Connecticut makes the collective knowledge and talents of highly experienced professionals in the fields of training, human resources, computing, networking, telecommunications and more, available to companies interested in implementing telecommuting programs.

Telecommute Connecticut has helped many companies make telecommuting work for them throughout the state of Connecticut. These efforts in turn reduce the number of employee work trips, decreasing traffic congestion, energy consumption and air pollution.

Adoption of Telecommute Connecticut as a statewide TDM tool elevates the awareness of Telecommuting as an option to reduce single occupant vehicle trips arriving at Connecticut employment sites daily.

TIP Amendment #170-3407 - FY-2016: Statewide Marketing

The Connecticut Department of Transportation (CTDOT) has the goal of reducing congestion on highways in the state. To help accomplish this, CTDOT will identify strategies for increasing awareness and usage of transportation alternatives to develop the optimal positioning for these modes of transportation.

- <u>Statewide Transit Marketing Vision</u>: This project will develop a statewide transit marketing vision for implementation of a regionally balanced program for transit marketing. The overall goal is to move public transportation towards becoming the mode of choice. This will include assessing existing efforts and interviewing stakeholders, developing a coordination process to support a cohesive brand for public transportation and developing a plan for one-call/one-click communication path for customers.
- <u>CTfastrak Marketing Support</u>: Support a continued outreach campaign for CTfastrak, Connecticut's first bus rapid transit project. Objectives of the outreach campaign include: reducing congestion on highways in the state; building a more positive and supportive environment for public transportation by building the brand based on the positive benefits alternative transportation provides; and capitalizing on the unique qualities within various geographies to strengthen the overall message.
- <u>Local Marketing/Outreach Initiatives</u>: In coordination with local Transit Districts, provide funding and oversight of local initiatives encouraging use of transit.

He explained that this CTDOT requested TIP amendment would revise a funding source from 100% federal to 100% state for Project 173-437, he noted the movement of federal to all state funding was what prompted the TIP Amendment.

Originally endorsed by SWRMPO in 2013, Project 173-437 will upgrade signals throughout CTDOT District 3. The one location of interest to SWRMPO is on Route 33 in Wilton near the intersection with Westport Road. He conveyed some detailing on the proposal provided by CTDOT. There was discussion. Then on a motion made by Robert Mallozzi and seconded by Jim Michel, the proposed TIP resolution was unanimously approved.

SWRMPO FFY 2015-2018

Transportation Improvement Program (TIP) Amendments (04/21/2016)

MPO Action Requested: Review and endorse TIP amendments using Resolution #2016-003

Background: The FFY2015-2018 South Western Region TIP was endorsed by the MPO on October 23, 2014. The TIP was incorporated into the larger Statewide TIP, which was approved by USDOT and EPA on January 21, 2015.

TIP Amendments (SWRTIP #Am2016-003):

135-301: Atlantic Street Railroad Bridge Overpass

The requested CTDOT Amendment is prompted by a transfer of construction funding and oversight from FHWA to FTA. An increase in the federal funding is also proposed, resulting from more refined project designs and scope. Movement of the project from FFY15 to FFY16 (the current year) is also included in this request. No local match is required for this project.

Originally endorsed by the SWRMPO in March of 2013, this project involves improvements to the Atlantic Street bridge overpass in Stamford. The roadway underpass will be widened to increase capacity and sidewalks will also be installed. Additional improvements will be made to the vertical clearance of the bridge, which requires the reconstruction of an I-95 off-ramp at Exit 8. The primary increase in federal funding amounts pertain to retaining wall work at Exit 8.

The three CTDOT requested TIP Amendments explained below pertain to funding received statewide as part of the federal Congestion Mitigation and Air Quality (CMAQ) program. The purpose of CMAQ is to fund transportation projects and programs that will improve air quality and reduce congestion. As an example, the South West Region MPO received CMAQ project funding in 2015 to help upgrade signal systems in Greenwich, Norwalk and Stamford.

The three programs being added to the SWRMPO TIP as a result of these amendments are described as follows:

TIP Amendment #170-3401 - FY-2016: Telecommuting Partnership

Telecommute Connecticut is a part of the CTrides program offered by the Connecticut Department of Transportation, with the support of the Federal Highway Administration. The program offers a comprehensive resource that helps employers design, implement and maintain telecommuting programs that, while being effective for employers, also result in reduced traffic congestion, energy consumption and air pollution.

Telecommute Connecticut makes the collective knowledge and talents of highly experienced professionals in the fields of training, human resources, computing, networking, telecommunications and more, available to companies interested in implementing telecommuting programs.

Telecommute Connecticut has helped many companies make telecommuting work for them throughout the state of Connecticut. These efforts in turn reduce the number of employee work trips, decreasing traffic congestion, energy consumption and air pollution.

Adoption of Telecommute Connecticut as a statewide TDM tool elevates the awareness of Telecommuting as an option to reduce single occupant vehicle trips arriving at Connecticut employment sites daily.

TIP Amendment #170-3406 - FY-2016: Statewide Marketing

The Connecticut Department of Transportation (CTDOT) has the goal of reducing congestion on highways in the state. To help accomplish this, CTDOT will identify strategies for increasing awareness and usage of transportation alternatives to develop the optimal positioning for these modes of transportation.

- <u>Statewide Transit Marketing Vision</u>: This project will develop a statewide transit marketing vision for implementation of a regionally balanced program for transit marketing. The overall goal is to move public transportation towards becoming the mode of choice. This will include assessing existing efforts and interviewing stakeholders, developing a coordination process to support a cohesive brand for public transportation and developing a plan for one-call/one-click communication path for customers.

- <u>CTfastrak Marketing Support</u>: Support a continued outreach campaign for CTfastrak, Connecticut's first bus rapid transit project. Objectives of the outreach campaign include: reducing congestion on highways in the state; building a more positive and supportive environment for public transportation by building the brand based on the positive benefits alternative transportation provides; and capitalizing on the unique qualities within various geographies to strengthen the overall message.
- <u>Local Marketing/Outreach Initiatives</u>: In coordination with local Transit Districts, provide funding and oversight of local initiatives encouraging use of transit.

TIP Amendment #170-3399 - FY-2016: Statewide Transportation Demand Management

Travel/transportation demand management (TDM) is an eligible usage of federal and state transportation funding and encompasses a diverse set of activities to support better decision-making for travelers choosing travel modes, times, routes, and locations. A goal of TDM is to optimize performance of local and regional transportation networks. Projects can help ease congestion and reduce single-occupancy vehicles.

Using selected contractors, CTDOT will market, educate and provide outreach to employers and individuals in support of CTDOT's regional rideshare program in the Southwest, Danbury, Bridgeport, Greater New Haven and Waterbury areas of the state. This program assists in the formation and long-term viability of carpools. This program is designed to reduce traffic congestion, energy consumption and air pollution.

<u>Task 1</u>: Southwest, Danbury, Bridgeport, Greater New Haven and Waterbury Services Supporting Carpools and Vanpools to Individuals

<u>Task 2</u>: Southwest, Danbury, Bridgeport, Greater New Haven and Waterbury Services Supporting Carpools and Vanpools to Employers

<u>Task 3</u>: Statewide Guaranteed Ride Program and Web-based Incentive Ride Network
