#### 1. MEETING CALL TO ORDER & ROLL CALL

#### 3. ACTION ITEMS

## a. Approval of TTAG Meeting Minutes - January 13, 2016

The TAG reviewed the proposed LOTCIP project selection process, created to organize and facilitate solicitations for the remaining available and anticipated funding. The process also included a 1-page project proposal summary and evaluation criteria worksheet. After discussing details and considering municipal needs, action was taken to approve the process and project proposal summary, while tabling action on the evaluation criteria pending additional edits and review by the TAG, and following a motion by Mr. Benson and a second from Mr. Michel, the motion carried unanimously.

#### a. Community Connectivity Program

Mr. Sachnin presented information on the Community Connectivity Grant Program. The TAG indicated interest in hearing a presentation from the program manager at upcoming meeting, if available.

#### b. MPO/ Transportation TAG Representatives

Mr. Sachnin advised that the SWRMPO would be asked to confirm and add information on MPO alternates, TAG members and alternates. He explained that the objective was to avoid confusion as to voting representation for each municipality, and address any gaps

that existed with vacancies, should the respective SWRMPO member wish to close such gaps and provide such coverage.

# c. CT Bike/Ped Plan & Map Update

A briefing on the CT state Bicycle and Pedestrian plan update, currently underway, was provided.

## d. NEC Future Tier 1 EIS

Mr. Sachnin informed the group of the Northeast Corridor Future Environmental Impact State, adding that the deadline for comments had been extended to February 15<sup>th</sup>, 2016.

# e. Future Guest Speakers & Topics of Interest

Mr. Sachnin brought attention to several studies which involve the region, including Route 1 Bus Rapid Transit Study lead by CTDOT, the CT Bike & Pedestrian Plan and Map Update, and the Northeast Corridor Future Tier 1 Environmental Impact Statement.
