RE: State Matching Grant Program (MGP) for Elderly and Demand Response Transportation

Overview: CTDOT has announced a new application process for the MGP, which provides matching funds for transportation of seniors and persons with disabilities to each municipality. Funding is calculated based on the land area and population of those over age 60. The program has been in place since 2006.

The funds cannot replace municipal funding for transportation services. If a town or city reduces its funding for senior/disabled transportation, the grant will be proportionally reduced.

Required Materials: applications are no longer required to access funds for this program. Municipalities need only submit the required certifications and budget information as follows:

- <u>Maintenance of Effort Certification:</u> should be completed and signed by the CFO. Please also include a copy of the municipal budget page for FY 18 that shows the line item for this transportation program.
- Assignability Certification: Those municipalities participating in a coordinated program through a transit district (NTD or HARTransit) should complete this form and have it signed by the municipal CEO assigning the grant to the transit district.
- **Program Budget**: The state has a new format for a two year program budget submission.

Deadline for certifications and budgets: <u>June 2nd.</u> All required materials should be sent electronically to: <u>Aimee.Marques@ct.gov</u>; <u>rsachnin@westcog.org</u>; <u>transit@westcog.org</u>, ricks@hartransit.com.

*applicants are encouraged to send materials in advance to Rick Schreiner, to confirm completeness prior to formal submission.

It is recommended that the grant program and sign off for the MGP certifications be placed on your municipal board's agenda ASAP so that applications are not delayed.

FTA Section 5310 Grant Solicitation: Richard Schreiner reviewed the current Federal Transit Administration 5310 Grant Program solicitation. Staff and transit districts are currently reviewing applications received. A CTDOT scoring process will be utilized and the results presented to the MPO. A request for MPO action to endorse project priorities is anticipated at the May 18th meeting.

CTDOT Matching Grant Program: Rick Schreiner reviewed a memo on this program attached to the agenda entitled "State Matching Grant Program for Elderly and Demand Response Transportation." This state funded program has been in place since 2006, and provides matching funds for the transportation of seniors and persons with disabilities in each municipality, he said.

Application requirements were discussed. An attached Maintenance of Effort Certification was reviewed. A table entitled "Total Fiscal Year 2017 Apportionments" provided a grant estimate for each of the eighteen municipalities.

Local Road Accident Reduction Program (LRARP): Rob Sachnin reported that Norwalk and Stamford had received conditional funding approval under the last grant cycle for this program. The 2017 solicitation will be similar to last year's, seeking to address safety problems on local roads with low cost, highly effective solutions.

The "target" project cap is \$500,000 in federal funding at 90% for the construction phase with the remainder as the municipal responsibility. WestCOG staff will work with municipalities to discuss specific locations and data details, he said. There was brief discussion.

FY2018 – 19 Unified Planning Work Program: Rob Sachnin commented on the upcoming two-year application for regional transportation planning funds. The total being applied for by both MPO's in the WestCOG area is approximately \$2.7 million. The two applications are highly detailed as they must be inclusive of many mandatory federal and state transportation planning procedures.

The drafts have been submitted to FHWA, FTA, and CTDOT for initial review, he said. After receipt of comments the revised drafts will be transmitted to COG, MPO and TAG, with endorsement action to be requested soon. Roxane Fromson contributed to the discussion.

Update on Transportation Alternatives Program: Rob Sachnin noted that the MPO advanced priorities to CTDOT last December. For the Danbury Urbanized Area CTDOT has reviewed the applications and selected Brookfield Four Corners. For the Bridgeport – Stamford Urbanized Area staff is working with Norwalk, Ridgefield, and Wilton to address CTDOT comments on their applications.

ACTION ITEMS

Approval of 3/16/2017 Meeting Minutes: After review and on a motion made by Matt Knickerbocker and seconded by Pat Llodra, the minutes of the meeting of 3/16/2017 were unanimously approved, except for an abstention by Sharon Calitro.

TIP Amendment Projects #34-309 and #34-345 in Danbury: As requested by Rudy Marconi, Rob Sachnin reviewed two CTDOT requested Transportation Improvement Program amendments. These were attached to the agenda as a memo entitled "HVMPO FFY2015-2018 TIP" and summarized by him as follows:

Danbury Project #34-309: Newtown Road widening at Old Shelter Rock Road, construction phase total at \$1,085,000. The proposal is to add left turn lanes and a traffic signal at this intersection, also realign the Old Shelter Rock Road approach. Project goals are to reduce congestion and improve safety. The TIP action is needed to revise the funding source from federal to state, which per CTDOT, will utilize previously bonded funding.

Danbury Project #34-345: Route 37 at Barnum Road, construction phase total at \$1,500,000. Originally endorsed by HVMPO in October of 2014, this project calls for widening shoulders at Route 37 northbound with Barnum Road southbound. The goal is to reduce congestion resulting from vehicles waiting to make left turns. The sidewalk along Route 37 will be extended north to the intersection with Barnum Road. The reason for the TIP amendment is that CTDOT proposes to utilize a higher federal cost share.

There was brief discussion after which on a motion made by Clay Cope and seconded by Matt Knickerbocker, it was voted unanimously to endorse the two Danbury related TIP amendment summaries and their financial details.

COMMENT AND DISCUSSION

Rudy Marconi raised issues concerning the slow pace of rehabilitation for the Route 35 bridge over the Norwalk River. Clay Cope expressed concern as to the CTDOT lane closure plan for Route 39 rehabilitation. Nina Daniel described the inconvenience to the public of unnecessarily slow roadway rehabilitation projects affecting Weston. Roxane Fromson contributed to the discussion.

ADJOURNMENT

Chairman Rudy Marconi stated that the next MPO meeting will be held at 11:30 am before the WestCOG meeting scheduled for 5/18/2017 at the Ridgefield Visiting Nurse Association in Ridgefield. Then on a motion made by Matt Knickerbocker seconded by Pat Llodra it was voted unanimously to adjourn the meeting at 12:05 pm.

HVMPO FFY 2015-2018 Transportation Improvement Program (TIP)

MPO Action Requested: Review and consider TIP amendment endorsement.

Background: The FFY2015-2018 Housatonic Valley TIP was endorsed by the MPO on October 23, 2014. The TIP was incorporated into the larger Statewide TIP, which was approved by USDOT and EPA on January 21, 2015.

Amendments (HVTIP #Am2017-004):

<u>0170-3450: FY17: Statewide Transportation Demand Management (NY-NJ-CT Moderate)</u> <u>0170-3451: FY 17: Statewide Transportation Demand Management (Greater CT Moderate)</u>:

This CTDOT-requested TIP amendment pertains to the Transportation Demand Management (TDM) program. TDM is an eligible usage of federal and state transportation funding and encompasses a diverse set of activities to support better decision-making for travelers in choosing travel modes, times, routes, and locations. A goal of TDM is to optimize performance of local and regional transportation networks. Projects can help ease congestion and reduce single-occupancy vehicles.

Using selected contractors, CTDOT will market, educate and provide outreach to employers and individuals in support of CTDOT's regional rideshare program throughout the state, including the Greater Hartford, Southwest, Danbury and Bridgeport areas under the name CTrides.

CTrides assists in the formation and long-term viability of carpools and vanpools. The program also provides comprehensive resources to help employers design, implement and maintain teleworking programs. This program will reduce the number of employee work trips, decreasing traffic congestion, energy consumption and air pollution.

CTrides has held events at several local businesses and government agencies in the HVMPO region, including the City of Danbury, Pitney Bowes, HARTransit, Western Connecticut State University, and many others. Specific actions include offering the NuRide ride matching and rewards program, delivering the Emergency Ride Home benefit, working with employers to support the commuter tax benefit, and operation of a statewide call center to answer commuting questions and offer customized commute plans.

A small portion of HVMPO falls within the CTDOT-designated Greater CT Moderate area for ozone pollution, while the remainder falls within the NY-NJ-CT Moderate area for ozone pollution and particulate matter pollution. For this reason, there are two TIP amendments pertaining to the HVMPO; one for each area.

MPO Action Requested: Review and consider TIP amendment endorsement.

Background: The FFY2015-2018 South Western Region TIP was endorsed by the MPO on October 23, 2014. The TIP was incorporated into the larger Statewide TIP, which was approved by USDOT and EPA on January 21, 2015.

Amendments (SWRTIP #Am2017-004):

0170-3450: FY17: Statewide Transportation Demand Management (NY-NJ-CT Moderate):

This CTDOT-requested TIP amendment pertains to the Transportation Demand Management (TDM) program. TDM is an eligible usage of federal and state transportation funding and encompasses a diverse set of activities to support better decision-making for travelers in choosing travel modes, times, routes, and locations. A goal of TDM is to optimize performance of local and regional transportation networks. Projects can help ease congestion and reduce single-occupancy vehicles.

Using selected contractors, CTDOT will market, educate and provide outreach to employers and individuals in support of CTDOT's regional rideshare program throughout the state, including the Greater Hartford, Southwest, Danbury and Bridgeport areas under the name CTrides.

CTrides assists in the formation and long-term viability of carpools and vanpools. The program also provides comprehensive resources to help employers design, implement and maintain teleworking programs. This program will reduce the number of employee work trips, decreasing traffic congestion, energy consumption and air pollution.

CTrides has held events at several local businesses and government agencies in the SWRMPO region, including the City of Stamford, the City of Norwalk, Norwalk Community Technical College, the University of Connecticut, Stamford, the Stamford Family YMCA, Empire State Reality Trust, and many others. Specific actions include offering the NuRide ride matching and rewards program, delivering the Emergency Ride Home benefit, working with employers to support the commuter tax benefit, and operation of a statewide call center to answer commuting questions and offer customized commute plans.

RE: Approval of Unified Planning Work Programs (UPWP)

MPO Action Requested: review and endorse FY2018 and 2019 UPWP's for HVMPO and SWRMPO, contingent upon administrative and technical adjustments to address any remaining CTDOT and USDOT comments. Draft copies have previously been circulated to MPO and TAG members for review.

Overview: An UPWP is a federal requirement for MPOs, outlining planning priorities and activities to be carried out during a defined period of time, in this case for a two-year period beginning July 1, 2017. A USDOT and CTDOT approved UPWP allows the MPOs to receive funding to carry out the transportation planning process, and remain eligible for receipt of federal-aid project funding in the region's municipalities. Historically, the UPWP has provided the largest source of revenue to WestCOG, which serves as staff to our MPOs.

The UPWP includes a mix of administrative and technical activities, addressing both federal requirements and areas of regional interest. Administrative examples include processing Transportation Improvement Program (TIP) amendments, meeting preparation and financial grant management, whereas technical activities may include bicycle and pedestrian planning, as well as support for ongoing studies such as the Stamford Bus and Shuttle Study.

Work Program Components: CTDOT's guidance identified the core requirements and activities, many of which are similar to the previous UPWP's, endorsed by both MPOs in May of 2015.

This includes federal emphasis areas such as compliance with MAP-21 and the FAST Act provisions. These are authorizing legislation for federal transportation programs and funding, which contain specific requirements that must be adhered to.

Planning activities include a transition to performance-based planning. Other emphasis areas seek to: promote cooperation and coordination across MPO and state boundaries; continuing the region's Ladders of Opportunity analyses, which identify transportation connectivity gaps that prevent access to essential services; and to improve the resiliency of the transportation system to natural hazards.

Other activities include but are not limited to: management of the TIP, updating the Long-Range Transportation Plan, safety and congestion analyses, transit planning, multi-modal mobility and connectivity, as well as freight planning.

RE: Prioritization of Federal Transit Administration Grant Applications

Each year the Federal Transit Administration announces the availability of the Section 5310 grant program, which was established in 1975 to enhance the mobility of seniors and individuals with disabilities. Grants from this CTDOT managed program provide up to 50% of operating costs and 80% of capital costs for a broad spectrum of transit projects. Eligible recipients of this program include qualifying non-profit organizations, state and local government entities.

CTDOT requires Metropolitan Planning Organizations (MPOs) to prioritize 5310 grant program applications affecting their respective regions. This year, 11 applications affecting WestCOG's two MPO regions were submitted for consideration. All 11 applications were independently reviewed and prioritized by staff from Norwalk Transit District, HARTransit and WestCOG, using application scoring criteria provided by CTDOT. One application was disqualified because of a missed deadline. Based upon this analysis, the following is the recommended prioritization of FTA Section 5310 applications for your consideration:
