CALL TO ORDER / PUBLIC COMMENT

The meeting was called to order at 12:08pm by Robert Sachnin. There was no public comment.

INFORMATIONAL ITEMS

Community Connectivity Grant Program: Robert Sachnin briefly reviewed from the attachment provided the grant program which is a part of Governor Dannel Malloy's Let'sGoCT!

MS4 Briefing/Update: This update was addressed by Michael Towle who discussed the Water Finance Clearing House and Nitrogen Strategy Workshop, as well as future goals in this program.

Regional Snow Plow Update & Working Group: Kristin Floberg updated the TAG Members, stating that she is the official point of contact for this project. She also stated that the interview selection committee has taken place and has chosen Axiomatic LLC. She went on to explain the qualifications possessed by Axiomatic LLC and the key time line points for this project.

ACTION ITEMS

Approval of 6/6/2017 Minutes: On a motion made by Mike Yeosock and seconded by Tracy Kulikowski the minutes of the TAG Meeting of 6/6/2017 were unanimously accepted.

LOTCIP Solicitation Methodology: This topic was addressed by Robert Sachnin, seeking to engage discussion regarding potential funding for LOTCIP. General direction was sought in respect to a future solicitation and methodology, contingent on additional funding. It was stated that open solicitation, hybrid, adhoc, or no action for funding could all be considered as options. On a motion made by Fred Hurley and seconded by Mike Zarba a hybrid open solicitation methodology with a reserve set aside, along with a hybrid two to four year financing option, were recommended as the general parameters for a future solicitation. The motion carried unanimously.

HVMPO Draft 2018-2021 Transportation Improvement Program & Air Quality Conformity: The federal transportation improvement program and corresponding CTDOT air quality conformity determinations for the Housatonic Valley MPO were discussed by Robert Sachnin. On a motion made by Antonio ladarola and seconded by Fred Hurley the HV Draft FFY 2018-2021 TIP project listings and air quality conformity determinations were unanimously recommended to the HVMPO.

SWRMPO Draft 2018-2021 Transportation Improvement Program & Air Quality Conformity: The federal transportation improvement program and corresponding CTDOT air quality conformity determinations for the South Western Region MPO were discussed by Robert Sachnin. Peter Ratkiewich stated that the administration of the Town of Westport has proposed the removal of Project #158-214 from the SWR Draft 2018-2021 TIP, pending forthcoming information based on the Environmental Assessment. He cited community concern due to the lack of information regarding the scope of improvements. This includes five line items, three of the which are for the construction phase, one each for final design and right of way. With the inclusion of the changes stated, a motion was made by Peter Ratkiewich and seconded by Tracy Kulikowski to recommend the amended SWR Draft FFY

2018-2021 TIP project listings and air quality conformity determinations to the SWRMPO. The recommendation was unanimous, except by the abstention made by Kimberlee Morton.

TAP Adjustments (if necessary): Robert Sachnin provided a brief status update to the group.

OTHER BUSINESS

Discussion Items as Raised by the TAG: Robert Sachnin discussed the possibility of the CHRO presenting to the TAG members at a future meeting. He also referenced the recent release of the FRA NEC Future ROD.

Local Transportation Capital Improvement Program (LOTCIP) Project Selection Process FY 2018-2021 Project Solicitation

1. Objective: this document lays out the process for project selection under the region's Local Transportation Capital Improvement Program (LOTCIP), guiding the selection of new projects as well as significant changes to existing projects. It is the goal of WestCOG to program funds in a manner that is orderly, equitable, and beneficial to the region.

2. LOTCIP Background: LOTCIP provides state funding for a variety of municipal transportation capital improvements, including: bridge rehabilitation and replacement; road reconstruction; intersection improvements; traffic signals; streetscapes; sidewalks; multi-use trails; and pedestrian bridges.

3. Eligibility: projects must adhere to CTDOT's revised <u>LOTCIP Guidelines</u> dated March 2016 and including any future revisions.

- Projects must be located on roads classified as urban collector or higher (see exceptions for bridge and transportation alternatives projects).
- Minimum project construction cost is \$300,000.
- Pavement preservation/rehabilitation and stand-alone sidewalk projects are capped at a maximum of 15% (combined) of annual LOTCIP funding to the region (+/-\$600,000 HV, \$1 million SW per year).
- Bridge improvements on roads classified as local are eligible if the span length is 20 feet or greater.
- Transportation alternatives projects are eligible. Although a specific cap has not been established, the amount of regional funding allocated to such projects is expected to be limited.
- Applicants: include the eighteen municipalities that comprise the Western Connecticut Council of Governments (COG).

4. Available Funding: is determined by using state LOTCIP funding of \$62 million in FY 2018 and \$64 million in FY 2019-2021, reserving a 25% contingency, and accounting for existing project commitments. Exact numbers are subject to change.

The region anticipates that the following amounts will be available for funding new projects:

- Housatonic Valley MPO \$11.6 million total FY 2018-21
- South Western MPO \$17.4 million total FY 2018-21
- Total WestCOG Region \$29.0 million total FY 2018-21

3. SWMPO Pending Cost Increases = \$274,825 Westport Main St. Sidewalks

<u>Maximum Project Award</u>: to maximize the number of projects and municipalities that can participate, a maximum cost of \$2,500,000 or less is recommended, with further flexibility as determined by the Technical Advisory Group (TAG) and COG.

<u>Outer Year Funding:</u> Projects programed for FY 2020 and 2021 funding may not initially advance LOTCIP projects until confirmation is received that CTDOT will accept associated project materials (i.e. applications, design submissions). FY 2020 and 2021 are included to assist member municipalities by aligning to their capital planning process.

5. Project Prioritization and Selection Criteria: priority may be given based on the following considerations and subject to TAG and COG approval:

- Adherence to CTDOT LOTCIP Guidelines
- Regional significance
- Readiness to proceed which may include, but is not limited to:
 - o Municipal track record of successfully advancing LOTCIP projects
 - Project complexity and design status
 - Critical path concerns: such as anticipated permitting, rights of way (ROW), and utilities
- Existing unfunded regional/MPO priorities
- Existing LOTCIP overprogrammed projects
- Safety
- Bicycle and pedestrian improvements
- Mobility and connectivity to existing transportation systems
- Equity
- 6. Project Review and Approval Process
 - <u>Municipalities submit projects:</u> for consideration using the WestCOG Project Proposal Summary form.
 - <u>Staff reviews projects:</u> for LOTCIP eligibility, confirm purpose and need, cost, etc.
 - <u>Staff evaluates and ranks projects:</u> using the project prioritization and selection criteria.
 - <u>TAG review:</u> of staff project evaluations and draft listing of projects proposed for funding, with discussion and revisions as warranted.

- <u>TAG recommendation:</u> of project priorities to the COG.
- <u>COG review and approval</u>: of TAG project recommendations, with discussion and revisions as warranted.
- 7. Municipal Responsibilities
 - <u>Commitment</u>: the Chief Elected Official shall commit to the project in writing, including commitment to design and completion.
 - <u>Match Funding</u>: LOTCIP provides up 100% funding for ROW and construction. Design and in some cases, ROW, are the responsibility of the municipality.
 - <u>Quarterly Reporting</u>: each municipality shall provide quarterly reports to WestCOG staff and the TAG regarding design progress and construction expenditures and schedule. Deadlines for submission are: September 30, December 31, March 31, and June 30.
- 8. Program Adjustments and Financial Details
 - <u>Cost Containment Policy</u>: any increases to cost in excess of ten percent (10%), after COG approval (assuming funding is available), will require the municipality to either:
 - Pay the difference (beyond the 10%)
 - Request review and approval of the TAG and COG to program addition LOTCIP funding (if sufficient funds exist) or reprogram as needed.
 - Scope Changes:
 - Municipally-driven: staff shall be informed of changes to project cost, scope, or priority as soon as possible. Depending on the magnitude of change, TAG and COG review may be required. Such additional review will be made on a project by project basis.
 - CTDOT-driven: The TAG and COG may periodically adjust project scopes of work and funding allocations based on CTDOT review comments, revised cost estimates, and other information that becomes available. Any resulting changes may also prompt TAG and COG review.
 - Delays, Adjustments, and Reprogramming:
 - Delays: in schedule may result in a recommendation by the TAG to reprogram funds (and action by the COG to do so). Such consideration will be based on a project by project basis, depending on the reason(s) for delay and impact to the overall programming of LOTCIP projects. Projects will be considered delayed, and will be subject to a mandatory project review by the TAG, if LOTCIP Applications are not submitted to CTDOT within 4 months from allocation of funds for the project by the COG and if Final Design Submissions are not made within 24 months from CT DOT issuance of a Commitment to Fund.
 - Available regional funding: (FY2018 & 2019) will be used on a first come, first serve basis and subject to TAG/COG approval. Projects programmed during this period experiencing delays referenced above may be adjusted to outer years to accommodate projects advancing more rapidly. Such efforts are required to obligate available funding and sustain overall program health.
 - Reprogramming: projects determined ineligible by CTDOT, those cancelled by the sponsoring municipality, and/or those experiencing delays may be removed from the program by the TAG and COG. Their allocations will be returned to the program and made available for other program efforts, such as cost increases and/or new projects. It is expected that priority consideration in reallocation of funds from cancelled projects will be given to the sponsoring municipality.
