RE: LOTCIP Program Update

SFY 18-21 Solicitation: The Region is currently soliciting for new municipal transportation projects. Projects must conform to the <u>2016 CTDOT LOTCIP guidelines</u> or its successor. Available funding is broken down as follows:

• HV sub region: up to \$11.6 million

• SWR sub region: up to \$17.4 million

Please note that funding for SFY's 20 & 21 is subject to future budget appropriations. Additional details on the regional solicitation may be found here.

Existing Program:

Advancing Projects: Timely advancement of projects is critical to sustaining overall program health and help ensure future appropriations. Although details are contingent on a variety of factors for each project, those expecting to go to construction in 2018 should be finalizing design at this point.

<u>Cost Adjustments:</u> At the December TAG meeting, representatives will be asked for direction in addressing program funding, including:

- Processing pending requests for increases in project costs in the short-term, which could be done as follows:
 - a) Approve cost increases for projects anticipated to reach construction in 2018 in December, January, and/or February, with the understanding that this may reduce the available funding for new projects from the 2018-2021 solicitation, or
 - b) Wait and consider cost increases (all or significant) together with new project applications submitted in response to the upcoming solicitation (this may delay some projects, but would allow all allocations of available program funds to be considered at the same time).
- Rolling surplus funds back into the program, for example, when the grant amount approved by
 the state (awarded bid plus 20% for contingencies and incidentals) is less than the amount
 budgeted by the region, and when unexpended funds exist at project completion and/or audit.
 This would increase the available funding for cost increases and new projects.

Quarterly Progress Reports to CT DOT: WestCOG will need updated project status information from towns that currently have projects in the LOTICP program for the quarter ending 12/31/17. Required information includes current cost estimates and anticipated final design completion and construction start dates for projects in design; and anticipated completion dates and the amount of expenditures of LOTCIP grant funds during the quarter (10/01/17 to 12/31/17) on construction, inspection, and materials testing, for projects in construction. Please provide the required information to Bob Brinton at rbrinton@westcog.org as soon as possible after 12/31/17.

CALL TO ORDER / PUBLIC COMMENT

The meeting was called to order at 11:02 am by Principal Planner Robert Sachnin. There was no public comment.

FEATURED PRESENTATION

Update from the CT Commission on Human Rights and Opportunities (CHRO): A presentation was made by CHRO's Deputy Director Cheryl Sharp, assisted by Executive Secretary Kristen Daniels and Contract Compliance Supervisor Alvin Bingham. They explained that the CHRO monitors state funded projects awarded by municipalities and other agencies for compliance with state anti-discrimination laws.

The bulk of their presentation focused upon review of a series of handouts detailing CHRO checklists and procedures. It was clarified that the enforcement process upon contractors is by CHRO, not by the municipalities engaging them or by other state agencies. There was considerable discussion, after which the CHRO staff members were thanked for their informative visit.

INFORMATIONAL ITEMS

Draft 2018 TAG Meeting Schedule. The schedule for upcoming 2018 was reviewed.

Regional Snow Plow Planning Update: Associate Planner Kristin Floberg updated TAG Members on the Snow Plow Planning Project. The consultant has completed the draft route organizations for all towns. These can now be reviewed, with the consultant to address comments, she said.

LOTCIP Projects Update. Rob Sachnin reviewed the Housatonic Valley and South West Region LOTCIP Projects Status Reports dated 10/05/2017. It was noted that continuation of this funding source has been included in the latest state budget. There was brief discussion.

ACTION ITEMS

Approval of 9/6/2017 Minutes: On a motion made by Jim Michel and then seconded by Bob Nerney, the minutes of the TAG Meeting of 9/6/2017 were unanimously approved.

Transportation Improvement Program: Jamie Bastian provided background on a proposed TIP amendment entitled "Housatonic Valley Project #0018-0136 Brookfield Town Center Pedestrian Improvements Phase 2." Selected for funding under the Transportation Alternatives Program, he noted that this project improves connectivity along Brookfield's Route 202 and leverages other improvements in this location.

Ralph Tedesco explained the merits of the project. Then on a motion made by Fred Hurley and seconded by Charlie Fisher, it was voted unanimously to recommend endorsement by HVMPO.

Draft LOTCIP Project Solicitation Methodology: Rob Sachnin reviewed the draft LOTCIP Project Solicitation Methodology attached to the agenda. He is seeking TAG input to be followed by a recommendation to WestCOG for its approval, after which the next project solicitation can be initiated.

There was then considerable discussion. It was agreed that clarity as to status of projects and their competitive environment would be enhanced if the selection criteria entitled "Existing LOTCIP overprogrammed projects" was deleted in Section 5.

Then on a motion made by Tony ladarola and seconded by Pete Ratkiewich, it was voted unanimously to recommend to WestCOG that it approved the Solicitation Methodology as amended.

Corridor Study Priorities: The agenda attachment entitled "CT Corridor Study Solicitation: Project Prioritization and Recommendations" was reviewed. WestCOG may submit a maximum of two applications to CTDOT.

Kristin Hadjstylianos then gave a PowerPoint presentation on this subject. There was discussion, with the following priorities recommended for advancement:

- Stamford: Washington Boulevard State Routes 493 and 137 Corridor Study at \$300,000 Danbury and New Fairfield: Routes 37 and 841 Corridor Study at \$200,000

On a motion made by Fred Hurley and seconded by Mike Zarba, the submission priorities above were approved unanimously as the TAG's recommendation to WestCOG, with Kim Morton abstaining.

OTHER BUSINESS

Discussion Items as Raised by the TAG: There was no discussion.

UPCOMING MEETINGS ADJOURNMENT

It was stated that the next MPO and COG meeting will be on 11/16/2017, with the next TAG meeting scheduled for 12/5/2017. The meeting was then adjourned at 12:45 pm.
