#### **CALL TO ORDER**

SWRMPO Chairman Jayme Stevenson called the meeting to order at 11:34am.

## **PUBLIC PARTICIPATION**

There was no public participation.

#### INFORMATIONAL ITEMS

**Draft 2018 MPO Meetings Schedule:** The draft meeting schedule, and the proposed January 18<sup>th</sup> Legislative Breakfast, was addressed.

**Draft 2018-2022 CTDOT Capital Plan:** Principal Planner Robert Sachnin reviewed the 5 year outline of possible funding. Although the Region may submit comments, the Capital Plan is a CTDOT document with no MPO action to take. First Selectman Jim Marpe noted that the improvements in

the Town of Westport regarding two intersections be addressed in the comments. Potential comments regarding rail were discussed.

CTDOT Corridor Study Solicitation: Principal Planner Robert Sachnin noted that the deadline for applications is October 17<sup>th</sup> and that the WestCOG staff lead is Kristin Hadjstylianos. The TAG will review and work to prioritize applications for MPO consideration with staff support, however awards are to be announced by CTDOT.

**TIGER Grant Opportunity:** Principal Planner Robert Sachnin addressed this topic, noting that applications for TIGER projects are due to the USDOT by October 16<sup>th</sup>. There was discussion regarding railway prioritization.

Freight Origin/Destination Data: Dedicated freight funding for a national freight network was discussed.

#### **ACTION ITEMS**

**SWRMPO Approval of 8/17/2017 Meeting Minutes:** After review and on a motion made by First Selectman Lynne Vanderslice and seconded by Mayor Harry Rilling, the minutes of the meeting of 8/17/2017 were unanimously approved.

SWRMPO TAP Adjustments: The transportation enhancements and improvements were discussed for the Bridgeport-Stamford Urbanized Area, which includes SWRMPO and portions of HVMPO. Adjustments to advance the Branchville TOD Infrastructure Improvements and the Norwalk Traffic Signal Upgrade – Phase 3, the latter contingent on CTDOT review of cost and eligible components, was recommended by the TAG. On a motion made by First Selectman Rob Mallozzi and seconded by Transportation Bureau Chief Jim Travers, the endorsement of the SWRMPO resolution was unanimously approved.

# **OTHER BUSINESS**

First Selectman Rob Mallozzi was honored and unanimously thanked for his contributions to both the HVMPO and SWRMPO.
