## HVMPO FFY 2018-2021 Transportation Improvement Program (TIP)

**MPO Action Requested**: Review and consider TIP amendment endorsement.

**Background:** The FFY2018-2021 Housatonic Valley TIP was endorsed by the MPO on August 17, 2017. The TIP was incorporated into the larger Statewide TIP, which was approved by USDOT and EPA on October 19, 2017.

#### Amendment #2019-0228:

#### 0034-0352: Routes 37 and 841 Corridor Study

This CTDOT-requested amendment is intended to add a new entry to the TIP for the City of Danbury and Town of New Fairfield. The amendment covers the entire study and will total approximately \$150,000. This will facilitate the development of traffic improvement measures on Routes 37 and 841 between the City of Danbury and Town of New Fairfield.

Funded through the Surface Transportation Program, the study is intended to solicit a detailed evaluation of the corridor for future improvements. Physical and operational characteristics as well as existing deficiencies will be addressed. The study will focus on ways to alleviate traffic congestion during peak travel hours, improve pedestrian mobility, and promote use of environmentally sustainable modes of transportation. The feasibility of a multi-use trail stretching from the Saw Mill Road intersection to Bear Mountain Reservation will be explored. Additionally, concept plans for proposed improvements will be developed.

## SWRMPO FFY 2018-2021 Transportation Improvement Program (TIP)

**MPO Action Requested**: Review and support TIP amendment endorsement.

**Background:** The FFY2018-2021 South Western Region TIP was endorsed by the MPO on August 17, 2017. The TIP was incorporated into the larger Statewide TIP, which was approved by USDOT and EPA on October 19, 2017.

#### Amendment #2019-0228:

<u>0301-0507: BUILD Discretionary Grant- Stamford Transportation Center Improvement FY18</u> This CTDOT-requested amendment is intended to add a new project to the TIP in the City of Stamford. The project would provide funding for improvements to the Stamford Transportation Center (STC). The STC is on the Metro-North New Haven Line and Amtrak's Northeast Corridor. The project is funded through the Better Utilizing Investments to Leverage Development (BUILD) Transportation Discretionary Grants program, solicited by the USDOT in 2018. Formerly named the Transportation Investment Generating Economic Recovery (TIGER) Discretionary Grant, the program invests in transportation infrastructure projects.

The STC's internal circulation system would be enhanced by upgrading approximately five elevators and seventeen escalators. It would also improve safety by including step demarcation lighting, continuous roller monitors, and a controlled stop braking system. These enhancements would reduce maintenance expenses and support increased transit ridership. This amendment covers the construction phase of the project which will total approximately \$22.9 million. The USDOT awarded CTDOT \$9.16 million through the BUILD program matched by \$13.74 million in state funds.
