CALL TO ORDER

INFORMATION ITEMS

Title VI Program Review: Associate Planner Nicole Sullivan spoke regarding the WestCOG Title VI Program Review. Based on the comments provided by CTDOT, WestCOG updated the *Title VI portion of the Title VI Civil Rights and Public Participation Plan*.

Safety Plan: Associate Planner Nicole Sullivan gave an update on the Regional Transportation Safety Plan. The plan is currently in the data collection phase. A kick-off presentation was held at the October TAG meeting.

2020 Safety Performance Measure Targets: WestCOG Senior Planner Kristin Hadjstylianos gave an update on annual safety performance targets. CTDOT established statewide safety targets in August, each MPO has 180 days to review these targets and decide if they want to support CTDOT's targets or develop their own targets.

ACTION ITEMS

2018–2021 Transportation Improvement Program: Associate Planner Nicole Sullivan reviewed the amendment to project #0135–0336: *Rehabilitation of Bridge No. 03682 over the Rippowam River in Stamford.* On a motion made by Stamford Transportation Bureau Chief Jim Travers and seconded by Weston First Selectman Chris Spaulding the TIP Amendment was unanimously approved.
