CALL TO ORDER/ PUBLIC COMMENT

INFORMATIONAL ITEMS

MS4 Update: WestCOG GIS Analyst Tucker Beckett gave an update on the MS4 infrastructure mapping project. WestCOG will be reaching out to all municipalities to verify the status of their infrastructure mapping and will be sending a link to a survey to all TAG members. Community Connectivity Grant Program: WestCOG Principal Planner Kristin Hadjstylianos gave an update on the Community Connectivity Program, which seeks to improve safety and accommodations for bicyclists and

pedestrians. This grant program will provide funding up to \$600,000 for local municipalities for construction cost related to these projects. All engineering, design, etc. must be covered by the municipality. Grant applications are due to CTDOT by Friday, October 16th. 2021-2024 Draft HVMPO and SWRMPO TIP Schedule: WestCOG Associate Planner Nicole Sullivan gave an update on the draft HVMPO and SWRMPO 2021-2024 Transportation Improvement Program (TIP). ACTION ITEMS

Approval of 8/18/2020 Minutes: After review and on a motion made by Greenwich Deputy Commissioner of Public Works James Michel and seconded by New Canaan Director of Public Works Tiger Mann, the minutes of the August 18th meeting were unanimously approved.

2018-2021 Transportation Improvement Program: After a review by WestCOG Assistant Planner Nicole Sullivan and on a motion made by Brookfield Project Manager Greg Dembowski and seconded by New Canaan Director of Public Works Tiger Mann, the SWRMPO TIP *Amendment#2020-0917: CTTransit – Stamford Facility Upgrades, Bus to Bus Discretionary Spending, Fiscal Year 2020* were unanimously approved as presented in the memo.

Updated Transportation Alternative Set-Aside Priority: Senior Project Manager Kevin Mahoney reported that the Town of Brookfield has withdrawn its application for federal Transportation Alternatives Set-Aside funds. By previous HVMPO resolution, the Brookfield and Danbury applications were ranked #1 and #2, respectively. Given Brookfield's action, the HVMPO should designate a new #1 priority. On a motion made by Brookfield Project Manager Greg Dembowski and seconded by Greenwich Deputy Commissioner of Public Works James Michel, TAG members unanimously approved a motion recommending that the HVMPO designate the Danbury City-Wide Enhancement of Pedestrian Mobility as its top priority for Transportation Alternative Set-Aside funding.
