CALL TO ORDER/ PUBLIC COMMENT

The meeting was called to order at 11:02am by Principal Planner Kristin Hadjstylianos. There were no public comments made.

INFORMATIONAL ITEMS

Winter Maintenance Update: WestCOG Deputy Director Mike Towle gave a demonstration on how TAG members can access the winter maintenance training video on the WestCOG website if they were unable to attend the December training session. Mike also shared the availability of snowplow optimization routes that were developed to account for reduced workforce due to COVID-19. These routes were shared with any municipality that requested the data.

UConn CIRCA Resilient CT: WestCOG Associate Planner Nicole Sullivan gave an update on the Resilient Connecticut workshop occurring on January 25th. Registrations are due by January 18th. Victoria Brudz, from Milone and MacBroom, gave an update on the progress made on the Resilient CT CIRCA project during December. Victoria also reviewed the current mapping of the Zones of Shared Risk. If you have any questions about the workshop or about the work being completed, please contact WestCOG staff members.

FTA Transit Safety Performance Targets: WestCOG Planner Todd Fontanella gave an update on CTDOT's proposed FTA transit safety targets for 2021. The next step is for TAG members to review and recommend endorsement of the safety targets at the February TAG meeting.

Congestion Mitigation Air Quality (CMAQ) Program: WestCOG Principal Planner Kristin Hadjstylianos gave an update on the Congestion Mitigation and Air Quality Program (CMAQ), which is a federal program that provides funds to transportation projects and programs that contribute to maintenance of air quality standards. WestCOG staff discussed that applications must be prioritized by the MPOs, the top three priorities will advance to CTDOT for consideration and will compete against applications from other MPOs in the state. Kristin stressed the importance of looking for projects that have regional significance. If you would like WestCOG staff to review and provide informal feedback on your applications, please send them to WestCOG by January 24th, with completed applications due to WestCOG by February 21st, 2021. WestCOG will provide an overview of the submitted applications and recommendations at the March TAG meeting.

FHWA Highway Safety Performance Targets for 2021: WestCOG Associate Planner Nicole Sullivan gave an update on CTDOT's proposed safety targets for 2021. After review and on a motion made by Newtown Director of Public Works Fred Hurley and seconded by Norwalk Assistant Principal Engineer Michael Yeosock, the highway safety performance targets were unanimously approved and will be presented to MPO members at the January meeting.

LOTCIP Adjustment: Senior Project Manager Kevin Mahoney presented a requested adjustment to the COG's LOTCIP project endorsements. On a motion made by New Canaan Director of Public Works Tiger Mann and seconded by Newtown Director of Public Works Fred Hurley, the TAG unanimously recommended approving the increase of the Brookfield Streetscape Phase project and will be presented to COG members at the January meeting.
