HVMPO Approval of 04/22/2021 Meeting Minutes: After review and on a motion made by Redding First Selectman Julia Pemberton and seconded by Newtown First Selectman Dan Rosenthal the minutes of the 04/22/2021 meeting minutes were unanimously approved with an abstention made by Bethel Second Selectman Rich Straiton.

**2021–2024 HVMPO Transportation Improvement Program** WestCOG Principal Planner Kristin Hadjstylianos provided an overview of the **HVMPO FFY 2021–2024** Transportation Improvement Program (TIP) Amendments #2021–0520

o170-3605: Statewide Transportation Demand Management (NY-NJ-CT Moderate) The CTDOT-requested amendment would add a new project to the TIP for the TDM program known as CTRides. The project would provide funds for Fiscal Year 2021 and enables CTDOT to market and educate employers in support of the program. The program aims to reduce the number of employee work trips and decrease traffic congestion by helping to form carpools as well as implement teleworking programs. The project total is approximately \$3.35 million with no local match.

After a review by WestCOG Principal Planner Kristin Hadjstylianos a motion was made by Sherman First Selectman Don Lowe and seconded by New Fairfield First Selectman Pat Del Monaco. The 2021–2024 Transportation TIP Amendments #2021–0520 was unanimously approved.
