The meetings were called to order at 12:02 p.m. by Chair Rudy Marconi and SWRMPO Chair Lynne Vanderslice.

Approval of the 02/16/2023 SWRMPO/HVMPO Meeting Minutes: After review and on a motion made by Darien First Selectwoman Monica McNally and seconded by Stamford Transportation Bureau Chief Frank Petise the minutes of the February 16, 2023 SWRMPO meeting were unanimously approved. After review and on a motion made by Redding First Selectwoman Julia Pemberton and seconded by Newtown First Selectman Dan Rosenthal the minutes of the February 16, 2022, HVMPO meeting were unanimously approved.

Approval of the COG o2/16/2023 Meeting Minutes: After review and on a motion made by New Milford Mayor Pete Bass and seconded by new Fairfield First Selectwoman Pat Del Monaco the minutes of the February 16, 2023 COG meeting were unanimously approved.

#### HV/SWR MPO Action Items:

Endorsement of the 2023–2050 HVMPO & SWRMPO Metropolitan Transportation Plan and the Ozone and PM 2.5 Air Quality Conformity Determination: WestCOG Senior Planner Kristin Floberg provided the review. After review and on a motion made by Bridgewater First Selectman Curtis Read and Seconded by Sherman First Selectman Don Lowe the Resolution to Approve the HVMPO Metropolitan Transportation Plan 2023–2050 was unanimously approved. After review and on a motion made by New Fairfield First Selectmoman Pat Del Monaco and seconded by Newtown First Selectman Dan Rosenthal the HVMPO Resolution to Approve the Conformity with the Clean Air Act in the Greater CT Ozone Nonattainment Area, CT portion of the NY-NJ-LI Ozone Nonattainment Area, and the CT portion of the NY-NJ-LI PM<sub>25</sub> Attainment/Maintenance Area was unanimously approved.

After review and on a motion made by Stamford Transportation Bureau Chief Frank Petise and seconded by Darien First Selectwoman Monica McNally the Resolution to Approve the SWRMPO Metropolitan Transportation Plan 2023–2050 was unanimously approved. After review and on a motion made by Stamford Transportation Bureau Chief Frank Petise and seconded by Darien First Selectwoman Monica McNally the SWRMPO Resolution to Approve the Conformity with the Clean Air Act in the CT portion of the NY-NJ-LI Ozone Nonattainment Area and the CT Portion of the NY-NJ-LI PM 2.5 Attainment/Maintenance Area was unanimously approved.

**2021–2024** Transportation Improvement Program (SWR & HV): WestCOG Planner Nicole Sullivan provided the review. After review and on a motion made by Stamford Transportation Bureau Chief Frank Petise and seconded by Darien First Selectwoman Monica McNally the 2021–2024 SWRMPO TIP Amendments were unanimously approved. After review and on a motion made by Redding First Selectwoman Julia Pemberton and seconded by Bridgewater First Selectman Curtis Read the 2021–2024 HVMPO TIP Amendments were unanimously approved.

SWRMPO Transit Representative: WestCOG Transportation Director Kristin Hadjstylianos provided a review. The Board members decided to nominate CTtransit Director of Rapid Transit & Zero Emissions Programs Barry Diggs and Norwalk Transit District Chief Executive Officer Matt Pentz to both serve as the SWRMPO Transit Representatives with each having one-half vote. After review and on a motion made by Stamford Transportation Bureau Chief Frank Petise and seconded by Westport First Selectwoman Jen Tooker the SWRMPO was unanimously approved.

Adjustment of Transportation Alternatives Set-Aside Priorities: WestCOG's Kristin Hadjstylianos provided the overview. This item pertains only to the SWMPO. After review and on a motion made by Stamford Transportation Bureau Chief Frank Petise and seconded by Darien First Selectwoman Monica McNally the Adjustment of Transportation Alternatives Set-Aside Priorities was unanimously approved.
