CALL TO ORDER:

The meetings were called to order at 12:27 p.m. by Chair Rudy Marconi and SWRMPO Chair Lynne Vanderslice.

Public Participation: There was no public comment.

MPO Bylaw Amendments: WestCOG Executive Director Francis Pickering described a proposed amendment to address an oversight in the current SWR and HV MPO Operating Procedures, whereby an MPO could lose its officers and no ability to elect replacements. The amendment would enable the WestCOG Executive Director to call a special meeting of the membership with the sole purpose of holding elections, when the offices of chair and vice chair are both vacant; allow holding the annual meeting (at which regular elections take place) as soon as December, once all CEOs have been seated; and to use a nominating committee to develop a proposed slate of MPO officers. After review and on a motion made by Wilton First Selectwoman Lynne Vanderslice and seconded by Darien First Selectwoman Monica McNally, the amendments were unanimously approved as the SWR MPO Bylaws. After review and on a motion made by Bethel First Selectman Dan Carter and seconded by Newtown First Selectman Dan Rosenthal, the amendments were unanimously approved as the HV MPO Bylaws.
