Legal Notice Announcing the Start of the Public Comment Period

The draft South Western Region Metropolitan Planning Organization (SWRMPO) 2027-2030 Transportation Improvement Program (TIP) is a dynamic list of all highway and public transit projects proposed to be undertaken utilizing Federal Highway Administration and Federal Transit Administration funding during federal fiscal years 2027-2030 within Darien, Greenwich, New Canaan, Norwalk, Stamford, Weston, Westport, and Wilton. The draft TIP is being updated and will be considered for endorsement at the SWRMPO meeting on May 21, 2026. It is being circulated beforehand to ensure that community concerns are properly included. In accordance with the WestCOG Public Involvement Plan, SWRMPO is initiating a public comment period which will begin at noon April 1, 2026 and conclude at noon on May 1, 2026.

Also considered for endorsement are the CT Department of Transportation (CTDOT) draft Air Quality Conformity Determinations for Ozone and Particulates. The draft TIP and draft Air Quality Conformity Determination documents are available for inspection at westcog.org beginning April 1, 2026.
